### Agenda

- 1. Reply to Owsla about TRDL Options.
  - a. Option #3, 2 Year Term Limit proposed
  - b. To do: Draft contracts of responsibilities, nominations and interviews at Fall PDF.
  - c. Dove has proposal that she has to send out for review. Will send it out this week.
  - d. Decision: Who is making decision and what it looks like (BOD or PC)
- 2. Land Update
  - a. No update yet. Expect to go on site visits this Fall.
  - b. Have some volunteers to help check out land, will try for commitments from those individuals.
  - c. Have the information they need to start reviewing properties, eliminating as
  - d. Dove has been talking with 1 or 2 real estate agents, working with properties with land leases on them, that can't do a lot on. Biggest issue is that land is generally swampland. Still working with one land in MD.
  - e. After Burning Man, Dove expects to have time to provide monthly updates.
- 3. Afterburn reports.
  - a. 3 or 4 departments have not yet turned in After Burn reports.
  - b. No consequences yet for coordinators that don't turn in AB reports. Consider options.
- 4. PONY Wrangler Art Grant consolidation/mediation
  - a. AG Committee doesn't have answers for most PONY questions. Will still need Burning Arts to evaluate projects.
- 5. Dave following up with the Vets about Road Construction, Mowing
  - Mowing: The mower was out of commission since it broke, goal to keep it 4-5".
    Mower has since been fixed.
  - b. Road: Still haven't gotten an estimate from Vets. Are Vets dragging their feet now or is it just an oversight?
  - c. Toilet Paper: Part of the concern is that people are defecating in the back field, neighbor's property. So will stock the portapotties extra at the clubhouse.

- a. Miss Fidget asked us to get any changes we want to make to her and Erica ASAP
- Updating references to Vets and who makes decisions and how. For instance, Vets can't directly tell participants something - instrutions have to go through Rangers / BOD / Coordinators, etc.
